The Johns Hopkins University Summary Annual Report for: The Johns Hopkins University Retiree Health Plan

This is a summary of the annual report for Johns Hopkins University Retiree Health Plan, EIN: 52-0595110, for the period 07/01/24 to 06/30/25. This is a welfare benefit plan offering health and dental benefits. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$14,953,593. These expenses include \$14,216,293 in benefits paid to participants and beneficiaries, and \$737,300 in other expenses. A total of 1,796 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$146,546,045 as of June 30, 2025 compared to \$137,793,386 as of July 1, 2024. During the plan year, the plan experienced an increase in its net assets of \$8,752,659.

This increase includes unrealized appreciation or depreciation in the value of plan assets, that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of the assets acquired during the year.

The plan had total income of \$23,706,252, including retiree contributions of \$10,554,592, and earnings from investments of \$12,225,660.
