Summary Annual Report for

The Johns Hopkins University 403b Plan

This is a summary of the annual report for Johns Hopkins University 403(b) Plan, EIN: 52-0595110 Form 5500, for the period 07/01/2016 to 06/30/2017. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits are provided by a trust and insurance annuity contracts. Plan expenses were \$221,376,036. These expenses included \$89,789 in administrative expenses and \$221,286,247 in benefits paid to participants and beneficiaries. A total of 38,655 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$4,968,337,135 as of June 30, 2017, compared to \$4,328,621,225 as of July 1, 2016. During the plan year, the plan experienced an increase in its net assets of \$639,715,910. This increase includes unrealized appreciation in the value of plan assets, that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of the assets acquired during the year. During the year, the plan had total income of \$861,091,946; including employer contributions of \$128,431,742, participant contributions of \$99,712,174, and earnings from investments of \$114,397,843.
