This is a summary of the annual report for the JOHNS HOPKINS UNIVERSITY TAX SHELTERED ANNUITY PROGRAM FOR FORMER EMPLOYEES OF JOHNS HOPKINS, (Employer Identification No. 52-0595110, Plan No. 001) for the period January 1, 2022 to December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a custodian (benefits are provided in whole from custodian funds). Plan expenses were \$6,130,128. These expenses included \$6,130,128 in benefits paid to participants and beneficiaries. A total of 589 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$72,920,950 as of December 31, 2022 compared to \$90,912,630 as of January 1, 2022. During the plan year the plan experienced a decrease in its net assets of \$17,991,680. This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$(11,861,552), including losses from investments of \$(11,861,552).

The plan has contracts with TIAA-CREF, and PRUDENTIAL RETIREMENT INSURANCE AND ANNUITY COMPANY which allocates funds toward individual policies.

PAPERWORK REDUCTION ACT STATEMENT
