This is a summary of the annual report for the THE JOHNS HOPKINS UNIVERSITY INCOME DEFERRAL 403(B) PLAN FOR RESIDENTS, INTERNS AND, (Employer Identification No. 52-0595110, Plan No. 005) for the period January 1, 2022 to December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

## BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a custodian (benefits are provided in whole from custodian funds). Plan expenses were \$4,081,905. These expenses included \$54,282 in administrative expenses and \$4,027,623 in benefits paid to participants and beneficiaries. A total of 5,929 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$82,975,624 as of December 31, 2022 compared to \$97,851,458 as of January 1, 2022. During the plan year the plan experienced a decrease in its net assets of \$14,875,834. This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$(10,793,929), including employer contributions of \$862,016, employee contributions of \$5,845,845, others contributions of \$250,933 and losses from investments of \$(17,752,723).

The plan has contracts with VARIABLE ANNUITY LIFE INSURANCE COMPANY, and TIAA-CREF which allocates funds toward individual policies. The total premiums paid for the plan year ending December 31, 2022 were \$0.
