Group Life Insurance Plan: The plan has a contract with Securian Life Insurance Company to pay all claims incurred under the terms of the plan. The total premiums paid for the year ending December 31, 2020 were \$4,819,337.

Travel Accident Insurance Plan: The plan has a contract with the ACE American Insurance Company to pay all claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2020 were \$97,503.

Long Term Disability Plan: The plan has a contract with the Hartford Life and Accident Insurance Company to pay all claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2020 were \$5,876,547.

Health Maintenance Plan: The plan has a contract with Kaiser Permanente to pay all claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2020 were \$3,063,086.

Short Term Disability Plan: The plan has a contract with the Hartford Life and Accident Insurance Company to pay all claims incurred under the terms of the plan. The total premiums paid for the year ending December 31, 2020 were \$3,310,199.

Accidental Death and Dismemberment Plan: The plan has a contract with Securian Life Insurance Company to pay all claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2020 were \$460,130.

Vision Plan: The plan has a contract with EyeMed to pay all claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2020 were \$882,216.

Group Accident Plan: The plan has a contract with Metropolitan Life Insurance Company to pay all claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2020 were \$271,007.

Critical Illness Plan: The plan has a contract with Metropolitan Life Insurance Company to pay all claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2020 were \$576,361.
