Summary Annual Report for Johns Hopkins University 403(b) Plan

This is a summary of the annual report for Johns Hopkins University 403(b) Plan, Plan 003, EIN: 52-0595110 for the period 07/01/2018 to 06/30/2019.

The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$247,249,304. These expenses include \$113,630 in administrative expenses, and \$247,135,674 in benefits paid to participants and beneficiaries. A total of 44,697 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$5,880,973,425 as of 06/30/2019, compared to \$5,508,126,845 as of 07/01/2018. During the plan year, the plan experienced an increase in its net assets of \$372,846,580.

This increase includes unrealized appreciation or depreciation in the value of plan's assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year.

The plan had total income of \$620,095,884, including employer contributions of \$149,501,526, employee contributions of \$112,699,534, and earnings from investments of \$292,000,322.

Paperwork Reduction Act Statement
